**Show Activities**—Several seminars are being planned for attendees, as well as soap carving for kids of all ages. There will be door prizes every half hour.

**Dinner**—We will not be holding a dinner on Saturday as we have in the past.

**Early Bird Bonus Drawing**—All exhibitors who submit their application and registration fee postmarked on or before June 30<sup>th</sup> will be entered in the Early Bird Bonus drawing. The winning exhibitor will receive a check for one (1) table rental space. The drawing will be held on Sunday, September 2<sup>nd</sup>.

**Where**—Illinois Building, Illinois State Fairgrounds, Springfield, Illinois

**Setup:** August 31 3 to 5 pm  
September 1 8 to 10 am

**Show Times** September 1 10 am to 5 pm  
September 2 10 am to 4 pm

**Purpose**—To stimulate interest in the art of woodcarving, wood turning, intarsia and woodburning.

**Competition**—There are nineteen competition categories with cash and ribbon awards.

There will also be three categories with ribbon awards only; no entry fee charged for these categories.

**Entry Fee**—Entries will be accepted from exhibitors having a paid table. No limit on number of entries per category; \$4.00 per entry. No charge for novice class, roughout or assisted carvings or woodburnings where ribbons only are awarded. Entries and fees will be accepted on Friday from 3 to 5 pm and Saturday from 8 to 9:30 am. **No entries will be accepted after 9:30 am on Saturday.**

#### **Cash Prizes**

Category prizes totaling over \$950 will be awarded and the club will sponsor three additional cash prizes.

\$75 Grand Champion Judges Choice  
\$50 Reserve Champion Judges Choice  
\$25 People's Choice

#### **Rules for Competition**

1. Judges decisions are final.
2. No limit on number of entries per category.
3. All entries for judging shall be carved or burned from wood within the past two (2) years.
4. Previous entries are not eligible.
5. Exhibit(s) shall be the work of the exhibitor.
6. Items for competition may be checked in on Friday, August 31 from 3:00 pm to 5:00 pm and Saturday, September 1 from 8:00 am to 9:30 am.
7. Chairman will guide placement into proper classes.
8. Ribbons will be given in each class plus Grand Champion, Reserve Champion and People's Choice.
9. "People's Choice" balloting will end at 3 pm on Saturday.
10. Entries will remain on exhibit until 4 pm on Sunday.
11. Exhibitor names can be attached to entries after judging is completed.
12. No mail in entries.
13. Competitors must have a table at the show.
14. Carvings and woodburnings from duplicators or kits, and roughout carvings from a class

situation or that an instructor has basically helped with will be placed in Group 21 or 22.

#### **CATEGORIES FOR COMPETITION: CASH AWARDS & RIBBONS**

- Group 1**—Caricature Animal (Single Animal, bird, fish)  
**Group 2**—Caricature Human (Single figure)  
**Group 3**—Caricature Scene (Human and/or animal)  
**Group 4**—Realistic Animal  
**Group 5**—Realistic Game Birds (Geese, ducks, Turkeys, Pheasants, etc.)  
**Group 6**—Realistic Raptors (Eagles, Hawks, etc.)  
**Group 7**—Song Bird  
**Group 8**—Realistic Fish  
**Group 9**—Realistic Human (Single)  
**Group 10**—Realistic Group Human or Animal  
**Group 11**—Chip Carving  
**Group 12**—Relief  
**Group 13**—Stylized (A creation of form but not necessarily the detail.)  
**Group 14**—Santa  
**Group 15**—Mythical  
**Group 16**—Bark Carving  
**Group 17**—Miscellaneous (Items that do not fit in one of the above categories, such as frames, gunstocks, furniture, musical instruments, decorative elements, moldings, signs, plaques, crests, emblems, lettering, jewelry, canes, walking sticks, whittled pieces.)  
**Group 18**—Woodburning (pyrography) Limited to items burned on wood.  
**Group 19**—Intarsia (A wood carving style consisting of various species of sculpted wood, assembled into a mosaic-like deep relief work of art.)

#### **RIBBON AWARDS ONLY-NO CASH PRIZES**

- Group 20**—Novice (Anyone who has carved two (2) years or less.)  
**Group 21**—Roughouts  
**Group 22**—Assisted carvings or woodburnings (Items done in a class or with help.)

**Restrictions**—All exhibits must be handmade wood carvings or woodburnings. No production pieces, art or crafts will be allowed.

**Fees**—\$45.00 per space; two tables and 2 chairs. Electricity charge \$5.00. (The Fairgrounds provides 5' or 6' tables based on what they have available.) Spaces are limited to two exhibitors.

Clubs that have been formed within the past two (2) years will be allowed more than two exhibitors. We are always happy to help a new club get started.

Exhibitors are required to provide their own table coverings, which shall cover the front and ends of their tables. No leaving the show early or you will not be accepted back to the next show. **Breakdown will be announced at 4 pm on the last day.**

Exhibitors may sell their carvings; the club does not charge a commission. Exhibitors are encouraged to demonstrate the art of carving or woodburning. A confirmation notice will be sent to the exhibitor. Please let me know if you need motel information.

**Other Activities**—Motorcycle Races. Other activities to be announced.
